City of San Jose Equity Policy & Ordinance

On May 14, 2024, the Mayor and City Council adopted the Racial and Social Equity Ordinance and the Equity Values and Standards Policy. This solidified San Jose's commitment to ensuring all residents thrive and have opportunities to live well. It also emphasized the collective responsibility of city leaders to make decisions that promote equity.

In the Equity Standards & Values Policy:

The City shall implement the following practices in its efforts to advance racial and social equity:

Anchor analysis in disaggregated data, both qualitative and quantitative, and longitudinal as applicable

LA County Anti-Racism Diversity & Inclusion



The State of Black Los Angeles County report provides the social and historical context that explains why racial disparities exist. The report's maps allow county officials to see the number and location of neighborhoods where disparities exist.

City Of Tucson, Arizona EQUITY DATA STRATEGY



A centralized repository of Decennial Census data, ACS data, and Esri's annual estimates processed for Tucson's unique geographic boundaries. The Hub will streamline access to census data by including the most frequently used variables pre-apportioned to the geographic boundaries most useful for research and analysis conducted by City of Tucson staff and community.

City of Tacoma, Washington



The Tacoma Equity Index measures entrenched economic problems, housing needs, and social justice issues. The tool examines five categories of inequity that include livability, education, environmental health, economic opportunity, and accessibility. These topics were analyzed with GIS technology to show patterns and represent inequities on a map.

Quick Notable Observations about Data

- Data disaggregation becomes the top highest-voted item in the Data category when totaling votes for all responses related to this concept.
- While the Data category saw the second-highest number of sticky note responses [n=13], more than half of them related to data disaggregation.
