You can do this by clicking "Raise Hand" under the "participants" menu, which you can find at the bottom of your screen on the Zoom platform, or by pressing *9 if you are joining by phone. The Commission staff member who is facilitating public comment will call on you upon seeing your raised hand. Commission staff will unmute your microphone when your name is called.

To make in-person public comment, please fill out the physical comment form provided during the meeting. Prior to making your comments, please state your name for the record and identify any group or organization you represent.

Timing of Comments:

Public comments will adhere to the length of time the chair announces during the meeting. Commission staff will share a timer and ask speakers to end when their time is up.
