### **Themes of Community Engagement**

- Concerns from community engagements: racial disparities involving issues of affordable housing access, lack of career readiness and civic education, decrease in job opportunities, further distrust and more.
- Feedback from community visits: The desire for more political and civic engagement and recognition/visibility of areas that are less represented or visible.

#### Response:

- Developing the Community Engagement Strategy (Framework)
- Contract with Global Urban Strategies

### **Contract with Global Urban Strategies**

- Global Urban Strategies provide innovative program design and management, community outreach, expert technical assistance, graphic design, social media, and web development.
- Support the Commission with community engagement and broader outreach
  → Framework rollout strategy
- Refine the Community Engagement Toolkit (survey) and execute the outreach strategies





#### **Elements of Community Engagement Toolkit**

Community Engagement Brief (Vital) and the Spectrum of Community Engagement informed the Community Engagement Toolkit

Goals:

- Center equity in engagement (language access, attendance support, etc.)
- Increase meeting access (ADA compliance for meeting locations, hybrid meeting option)
- Honor unique identities and lived experiences
- Listen to community needs, answer questions, and receive feedback to inform the Framework



### Learning from Community

- Return to the locations visited by the Commission to share updates about the Framework and maintain community connections.
- Take lessons learned from Meet-n-Greets and Listening Sessions to inform the Framework
- Summarize Community Meet-n-Greets and Listening Sessions in writeups

### **Community Engagement Best Practices**

#### **Asset Analysis Highlights**



How does your organization distribute information intended for the public, for example, how to engage with the agency or information about a newly available opportunity or resource?



**Organization website** was the most common method respondents reported using to share information intended for the public.

### **Community Engagement Best Practices**

#### 12/19 Discussion Results: Community Engagement

#### **Quick Notable Observations about Community Engagement**

- Tribal engagement was overwhelmingly the top voted priority, with votes for this item exceeding that of the second highest-voted item by nearly double.
- Three out of four Community Engagement Committee Members emphasized the *need for dedicated resources as a formal budget line item* (e.g., to fund efforts such as providing translation for language access, incentives for community participation, etc.).





### **Community Engagement Best Practices**

#### 3/20 Discussion Recap

Initial Community Engagement Recommendations:

Institutionalize a State approach to community engagement (e.g., Community Engagement Toolkit)

2 Meet community where they are

- Collaborate with trusted partners
- Engage community-based organizations (CBOs)
- Use accessible language
- Be responsive to different cultures
- Engage community outside of normal business hours
- 3 Address barriers to participation
  - Explore ways to provide childcare, food, etc.

#### Other community engagement elements to include in building the racial equity framework:

- Understand the importance of being accountable to community members
- Seek feedback from CBOs in the iteration of the racial equity framework
- Explore potential changes to meeting process to grow community voice in Commission meetings
- Include examples of effective community engagement and the importance of community engagement in the framework
